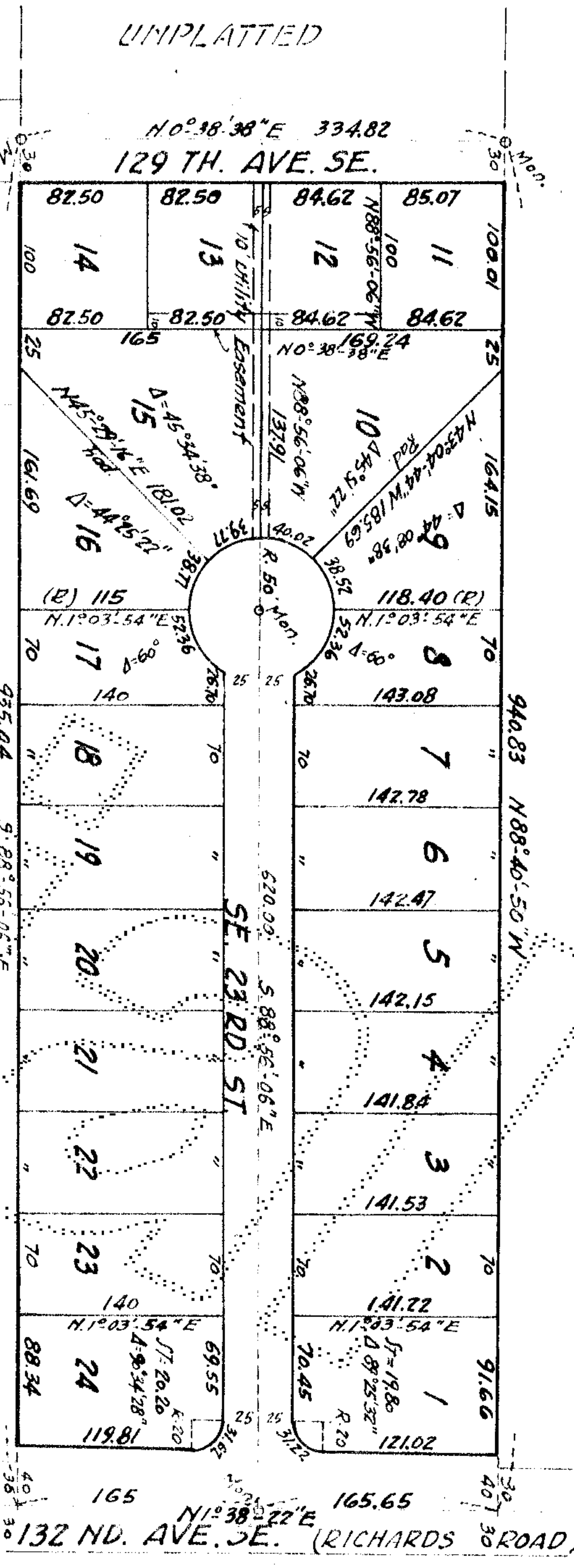


INLAND PARK NO. 2

KING COUNTY, WASHINGTON

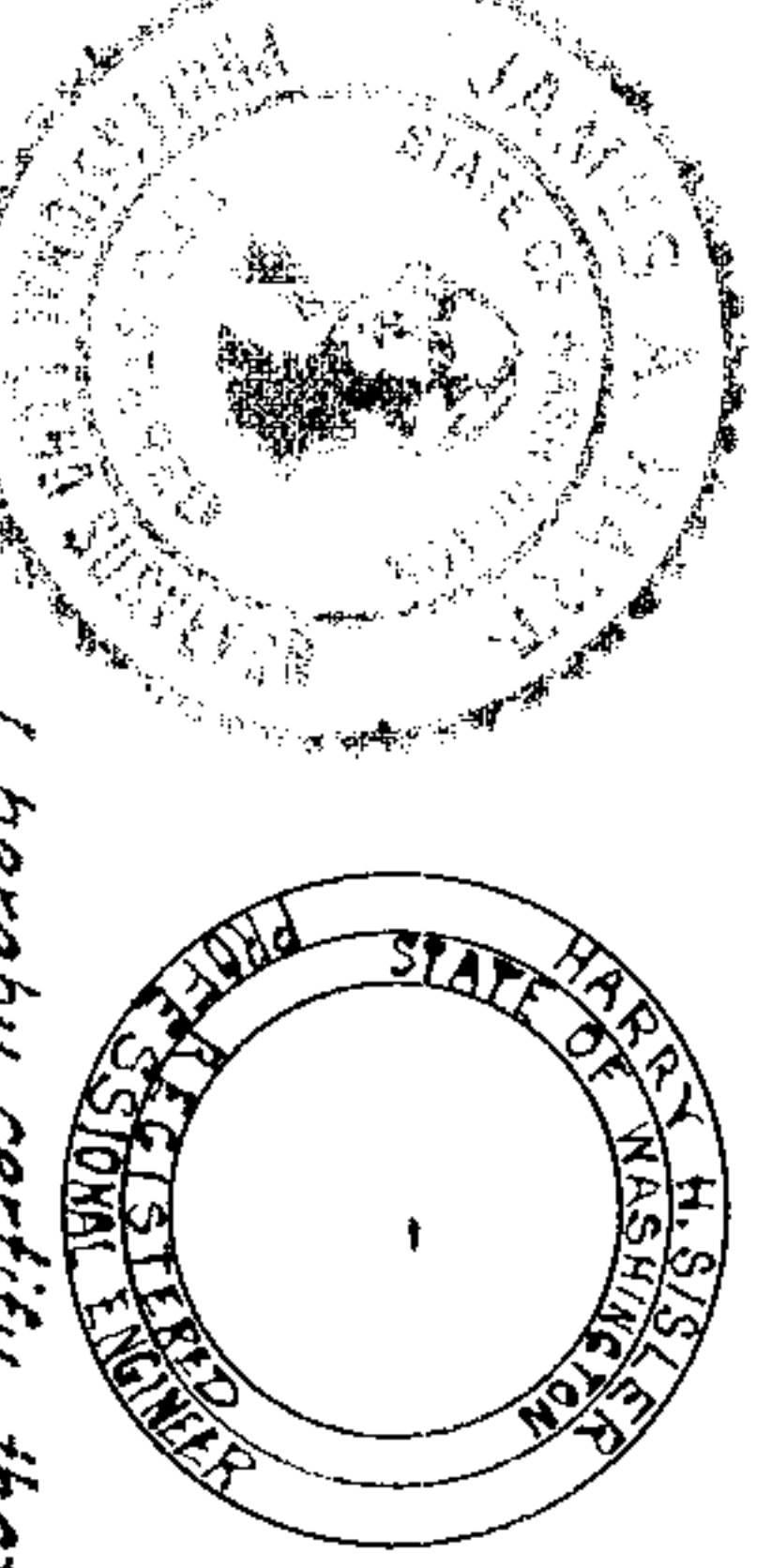

DESCRIPTION
This plat of Inland Park no. 2, on addition to King County, Washington, embraces the SE 1/4 of the SE 1/4 of Section 4, Township 24 N, Range 5 E, W.M.; Except, the north 150 feet; and, Except, the south 235 feet; and, Except, the west 310 feet; and, Except, the east 30 feet for County road.

RESTRICTIONS
No lot or portion of a lot in this plat shall be divided and sold, or resold, or ownership changed or transferred, whereby the ownership of any portion of this plat shall be less than the area required for the use district in which located.
